Law of One (Missing) Teachings

The Law of One (LOO), perverted version, or what can be called "the half teaching" is the bane of the Universe and always leads to the downfall of a Society. Demographics

They can't live off Investment Returns anymore, as Investments will generally be losers for the next decade.

Student Loan, School Lunches and Credit Issues (Housing too)

Student Loan Fixes

The problem with the existing Student Loan forgiveness program is that most people are eligible for it!

- It was supposed to be for those sacrificing to serve their communities
- By allowing "ANY" non-profit employment, it became a free-for-all, as most people qualify.
- It became a slush fund for colleges to charge what they want for education.
- Basically, work for any non-profit for 10 yrs., pay 10% of income, and Gov. pays the rest!

Alternative Programs Need to be Created and Allowed to Be Used, Simple Programs

- Consider Dollar-for-Dollar payoff programs, meaning shared payoffs, not free!
 - o Focus these on non-critical professions, general non-profit employees.
 - Certify non-profits using a minimum score on B-Corp analysis.
- For actual high-risk and social careers make it 2:1
 - The enhanced program should focus on critical and high-risk professions.
 - The program should focus on limited careers; fire, police, doctors, nurses, etc.
- How would this roll-out work? How to make it happen with today's programs?
 - Create the new programs and allow for "voluntary" enrollment.
 - Make it easy to transfer to "new" program" from current loan forgiveness program.
 - Lay out simple criteria to be eligible and per-approve people prior to transfer.
 - Make the program simple to enroll in and understand.
 - Approve people within 90 days and make approval easy, they'll all voluntarily switch!

School Lunch Insanity

Why is it that School lunches are no longer included in education, meaning we charge kids for them?

- It is outrageous that school lunch has been deemed a "luxury" that must be paid for!
- School lunches are an inherent part of education.
- We are feeding "kids" not adults!
- It should be criminal to charge kids for 'basic' school lunches!
- School lunch is NOT a "revenue" stream for funding cafeteria's, as they are part of schooling.

Credit Rating and Housing Crisis (Homelessness) Items

Why are "Late" Payments allowed on credit reports for up-to 10 years?

- Late payments are counted on credit scores and held for up-to-10 years
- Why are late payments treated the same as "bankruptcy's"?
- It is time to review the criteria used on Credit reports and limit some criteria!

Why focus only on Subsidies for apartments, etc.?

- If you have bad credit, you can't get approved to rent, even with income!
- Create a new "guarantee" program under Fannie May/Freddie Mac to guarantee rents.

Homeless Crisis and Credit

- If someone is homeless, they have bad credit.
- If they get a job making \$100k, they still have bad credit and can't rent housing! (especially in tight markets)
- Basically, we need a first step program to guarantee rent, not just a subsidy system!

Student Loan Items

College Items (future debt issues)

- They must disclose "all-in costs" as many only advertise Tuition, yet require on-campus living
 - Federal Grants only apply to Tuition
 - Eligibility for Loans is based on Tuition
- They must disclose Number of Students getting Financial Aid
 - Disclosure must be done by 'percentage of aid" provided, i.e. 90%+, 80-90%, etc.
 - Disclosure of actual number of students getting "zero" aid, including all fees
- If they have Trust Funds, they must distribute 5%+ per year, minimum, strictly for Scholarships
 - Scholarships must include Tuition and all Fees and are Income Based
 - o If there are excess funds available, then increase income threshold for assistance
- Must clearly disclose full all-in costs of a 4-year, or 5-year, degree clearly
 - Must also disclose average income by degree and estimated pay-back period/terms
 - Basically, disclose the ROI...how many years, etc.

Corporate/Non-Profit Programs (existing loan issues)

- New Treasury Rules for Tax Treatment of Student Loan Debt
 - o Increase allowed amounts of Corporate payment of Student Loan Debt
 - Allow Corporate full write-off or tax credit for paying off Employee Student Loan debt
 - Allow Employees the pay-off of the Student Loan debt as "Non-Taxable" Income
 - \circ $\$ Payoff/write-off amounts can be amortized over 5 years or 10 years
- Fundamentally, the idea is to allow Corporations/Non-Profits, etc. to expense the payoff of Employee student loans, as non-taxable income to EEs, and do it as a part of an employment agreement/contract.
 - There could be a limit of \$20,000/year for up-to 10 yrs., higher for Medical Doctors.
 - Advance payments could be allowed; and if EE leaves prior to the end of the period, then the EE would be liable to pay back the ER, or the ERs designated servicer, as it would in effect be a reinstatement of remaining loan amount, unless the payoff plan is paid by or assumed by future employer, especially in the case of divestures/acquisitions.

Education Items

Public School Education Funding

- The biggest control mechanism is the dysfunctional Title I and IDEA grants, and all grants!
- By utilizing "line" items and allocating spending 'by-line', allows no flexibility.
- The system also forces schools to spend money on items they may no longer need.
- The system allows almost 'no flexibility' if financial situations change, limited allocations.
- Better way... Pseudo-Block Funding!
 - Blocks of funding for Salary & Benefits, All School Related Supplies, and Support Services, instead of lines 100. 200. 300, etc. with sublines.
 - IDEA funding go be split in a similar fashion; specific to supporting Special Ed.
 - Special Ed...school districts should be able to merge programs and create regional programs.
 - These would-be Public-School programs, not outsourced programs that exist today.
 - This would mean 1 set of admin staff instead of multiple staff, etc.

Regulations

There is a complete lack of understanding that Democrats abuse regulations to change laws. PPACA regulations re-wrote the law. (not legal) In addition, it is highly likely that over the last 20+ years, Democratic appointees re-wrote a lot of laws using regulations. The real 'Executive Order" should be to evaluate 'all' existing regulations to see if any of the regulations super-ceded the laws that they were issued to support!!!

Medicare and Medicaid Items

There appears to be "fear" to use the existing legal authority within Medicare and Medicaid Laws. The number one failing on the part of CMS is that they "forget" that under Medicare and Medicaid, many generally legal businesses practices are 'deemed' to be 'illegal' and carry felony charges with them.
